Our website collects and uses personal information for the following reasons:

Site visitation tracking

This site uses Google Analytics (GA) to track user interaction. We use this data to determine the number of people using our site, to better understand how they find and use our web pages and to see how they move through the website.

Although GA records data none of this information personally identifies you to us. GA records your computer's IP address which could be used to personally identify you but Google do not grant us access to this. We consider Google to be a third party data processor (see section 6.0 below).

GA makes use of cookies, details of which can be found on <u>Google's developer guides</u>. FYI our website uses the analytics.js implementation of GA.

Disabling cookies on your internet browser will stop GA from tracking any part of your visit to pages within this website.

Our blog

Although we currently do not allow comment to any posts that we have published on our blog, should this change, the name and email address you enter with your comment will be saved to this website's database, along with your computer's IP address and the time and date that you submitted the comment. This information is only used to identify you as a contributor to the comment section of the respective blog post and is not passed on to any of the third party data processors detailed below.

Your comment and it's associated personal data will remain on this site until we see fit to either

1.) remove the comment

or

Our SMTP servers are protected by <u>TLS</u> (sometimes known as SSL) meaning that the email content is encrypted, 256-bit cryptography before being sent across the internet. The email content is then decrypted by our local computers and devices.

These are mainly found in our Blog posts and How to Articles However they can be used website wide, we would like to make it clear that once you have used these links you would be leaving our site, you should note that we do not have any control over that other website.
